INVESTMENT OBJECTIVE

The fund aims to outperform the Euro Stoxx Net Return benchmark index (net dividends reinvested) over the recommended investment period (5 years), in particular by selecting stocks that meet socially responsible investment criteria.

INVESTMENT PHILOSOPHY

Through an "opportunistic" investment strategy, the fund seeks and selects companies in the Eurozone without imposing any particular sector or geographical constraints. Through this approach, the fund can therefore combine several management styles: "value" (companies considered undervalued and neglected by investors), "growth" (companies that the manager believes are growing and driven by new markets) or "quality" (mature companies recognised for their robust model).

This fund, which is eligible for the PEA, seeks to capture, from a medium-term perspective, the upside potential offered by a selection of stocks whose market value does not reflect their real value according to the managers' analysis.

This discretionary management does not aim to duplicate its benchmark and may require a contrarian approach as managers' expectations may differ from the market consensus.

DNCA Opportunités Zone Euro, which has been awarded the SRI label, takes extrafinancial criteria into account to exclude stocks with a risky profile in terms of corporate responsibility or exposed to major controversies.


